

ARTICLES OF ASSOCIATION - Association for Social Development and Support

The following persons have come together on March 4, 2012 at the registered office of the association to be founded, in via G. Amendola 27, Ussana (CA), Italy:

who mutually agree and stipulate as follows:

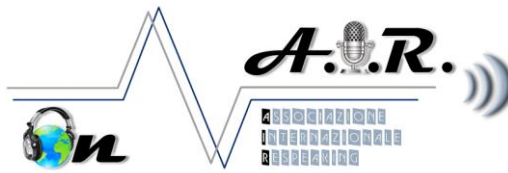
Art. 1 – The above mentioned appearers, as founding partners, found a free Association for Social Development and Support (according to Law 383/00) called “onA.LR”.

Art. 2 – The Association is a free union of people, is not for profit and carries out socially useful activities for the benefit of its members as well as of third parties.

Art. 3 – The registered office of the Association is in via G. Amendola 27, Ussana (CA), Italy. Its office can be moved to any other place following a decision by the Partners Meeting.

Art. 4 – The only purpose of the Association is to pursue the following goals:

- 1) the enhancement, study, research and popularisation of subtitling (mainly by means of respeaking, but also of other techniques) for any television, radio, cinema or other kind of event, in Italian and in other languages, as a tool to foster social inclusion for foreigners, deaf people and other disadvantaged categories;



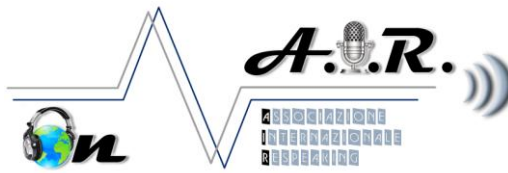
- 2) the incentivization of communication, cooperation and active participation of the young in the local, national and international community by means of:
- A. the production, distribution, organization and subtitling (mainly by means of respeaking, but also of other techniques) of cinema, television and theatre shows, concerts, entertainment events and artistic activities in general, both in public and in private settings, both outdoors and indoors, also in schools, public and private organizations;
 - B. the promotion of the use of respeaking for minutes and report writing as well as in all the other applicable fields;
 - C. multimedia initiatives, conferences, conventions, seminars, debates, training courses, events aiming at promoting subtitling as a tool of social inclusion and career opportunity;
 - D. publishing and distributing articles, magazines, news-sheets, CDs, DVDs as well as any other instrument promoting and spreading respeaking and subtitling in general;
 - E. any other activity and/or service aiming at achieving the goals of the Association;
 - F. contacts with companies, associations, universities, public institutions, local government units, tourism and sport organizations in order to reach the goals of the Association;
 - G. carrying out any other task assigned by the competent authorities according to the relevant rules and regulations or by decision of the Association itself.

To this end, the Association can launch all the necessary and appropriate initiatives in compliance with the Statute of the Association and with the laws in force.

Art. 5 – The Association shall have perpetual existence.

Art. 6 – The Association is non-partisan and non-denominational.

Art. 7 – The founding members adopt the Statute, which is attached to this deed under letter A, being an integral part of it, and which they sign and approve, to govern and regulate the Association. The Association will follow the following guiding principles, which are analysed in detail in the Association's Statute attached: non-profit nature, democratic nature of the structure, elected nature of the offices within the association, the mostly free nature of the services provided by the members as well as of anything else necessary for the legal formation of an Association qualifying as Association for Social Development and Support.



Art. 8 – The attending founding partners approve the membership fee for the first year in the amount of € 10.00 for each physical person and of € 50.00 for groups, to be paid to the Association to build the social fund. The following contributions shall be suggested by the Board, approved and ratified by the ordinary Partners Meeting during the budget approval meeting.

Art. 9 – The founding members hereby establish that the first Board shall be composed of 5 members. The Constituent Assembly decides to immediately appoint Dott.ssa Francesca MARCHIONNE as President and to appoint the following members of the Board:

- 1) Carlo EUGENI
- 2) Antonella FERRAIUOLO
- 3) Natascia INNAMORATI
- 4) Francesca MARCHIONNE
- 5) Tiziana TRAPANI

By signing at the foot of this deed, the above mentioned appointed persons accept and declare there are no causes for their ineligibility and/or incompatibility according to Art. 2382 of the Italian Civil Code.

Art. 10 – The Constituent Assembly decides to immediately appoint Ms. Tiziana TRAPANI as Vice-President.

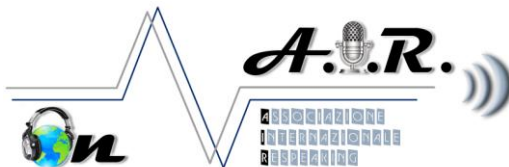
The Constituent Assembly decides to immediately appoint Ms. Antonella FERRAIUOLO as Treasurer.

The Constituent Assembly decides to immediately appoint Prof. Carlo EUGENI as Human Resources Director.

Art. 11 – The founding members give the President the mandate to register the present deed and to execute further necessary duties.

Art. 12 – The first financial year shall end on December 31, 2012.
